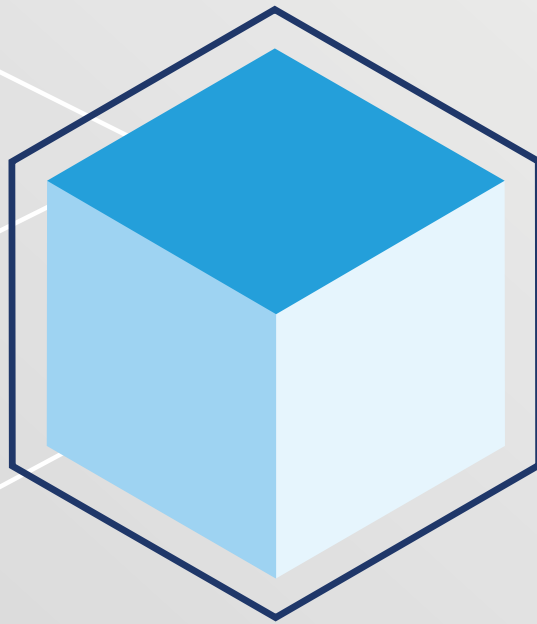

## BUILDER BONUS

Available for Leader, Diamond and Presidential Diamond ranks

**The Builder Bonus is the best way to help your business grow. Take advantage of this incentive and encourage your team to do the same. You'll see your organization increase in strength month after month.**

- **The first month**, sign up two new customers or distributors each with an order of 200 LP and make your own Loyalty Program order with 125 LP.

During this first month, your new enrollees must sign up on the Loyalty Program with a monthly order of at least 125 LP.

- **If on the following month** you and your new members receive a Loyalty Program order of at least 125 LP, you have won the Builder Bonus! You'll receive **80 euros** on the third month.
- For every two new members that join your 4Life project and meet the requirements over a period of two months, you will enjoy another Builder Bonus of **80 euros** on the third month. And so up to a maximum of **320 euros** in a month.



## TERMS & CONDITIONS • EUROPE

1. The Builder Bonus is open to distributors that has the rank of Leader, Diamond or Presidential Diamond.
2. A distributor must enroll two new 4Life® customers or distributors in the same month, each with 200 LP (or more) in product purchases.
3. In their second month, those same two new team members must receive a 125 LP (or more) Loyalty Program order, and maintain active the Loyalty Program during the incentive period.
4. The distributor enroller must also personally have a 125 LP Loyalty Program order both months to qualify for the Builder Bonus.
5. New distributors and customers must reside in markets where 4Life has an office.
6. When a distributor meets these requirements, he or she earns a 80 euros Builder Bonus.
7. For every two additional new team members who meet the same qualifications over two months, the distributor enroller earns another 80 euros Builder Bonus—up to 320 euros in one month.
8. Builder Bonus program is designed for Europe and for any where 4Life has an office.
9. Special conditions apply to the Italian market.



## BUILDER BONUS — QUESTIONS & ANSWERS

1. **Should the 200 LP in the first month be all in the same purchase?**  
NO. The 200 LP can be obtained from several purchases. The important thing is for the total accumulated LP in the first month of each new Distributor (or customer) to add up to 200 LP or more.
2. **Can my new customers qualify for the Builder Bonus?**  
YES. Your new enrolments can qualify for the Builder Bonus whether they are Distributors or Customers.
3. **What points count for my new enrolments to accumulate 200 LP from the first month?**  
The following count for the 200 LP: I) purchases made using the code of each new enrolment; II) Loyalty Programme orders using the code of each new enrolment; III) transfers of points from one LP CENTER and/or other distributor to the new code; IV) purchases in the new Distributor's My4Life.
4. **When should I have points with the new codes after the enrolment date?**  
During the enrolment month.
5. **When am I paid the Builder Bonus?**  
Once the requirements for the first and second months are met, the Builder Bonus is paid between day 15 and day 20 of the third month.
6. **What is the minimum that I can earn with the Builder Bonus?**  
In the third month €80 is earned for each pair of new enrolments that accumulate 200 LP each during the first month and receive a Loyalty Programme order of at least 125 LP in the second month.
7. **What is the maximum that I can earn with the Builder Bonus?**  
In the third month you can earn up to a maximum of €320. To earn this, you must have 8 new enrolments, in other words, 4 pairs. IMPORTANT: having more than 8 new enrolments does not increase the third-month bonus.
8. **How many can I earn if I have 5 new enrolments?**  
You can earn €160 since 2 pairs of new enrolments would be considered.
9. **Is it sufficient to be a sponsor to qualify for the Builder Bonus?**  
To qualify for the Builder Bonus, you must be the enroller of the new Distributor (or customer). If you enrol a distributor, they don't have to be in your Frontline. You just have to be their sponsor.
10. **What day of the month is the last day to include my new enrolments?**  
The last business day of each month.
11. **Can I earn a Builder Bonus if my new Distributors enrolled have not signed the contract?**  
NO. In Spain, to qualify for the Builder Bonus, you must ensure that 4Life Research Spain has received by post the original contract (and other documents) of your new distributors within 30 days from the enrolment code. Without filling the contract, your new enrolments cannot be considered Distributors.
12. **Do my new Distributors have to purchase the business Kit for me to earn the Builder Bonus?**  
It depends. Your new Distributors only have to purchase the Kit Corporate if they have codes from Germany, Spain or Italy.
