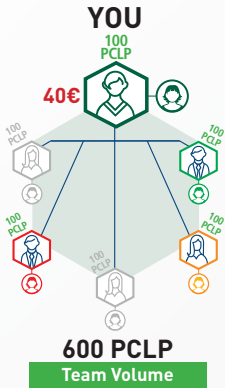

The Builder Bonus will help you build your 4Life organisation in the most efficient way. To earn the Builder Bonus you must qualify for the rank of Builder and fulfil the required Team Volume.*

How to get a monthly bonus of €40

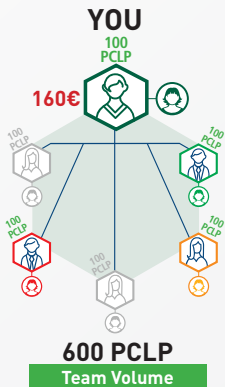


- You must be at the Builder rank
- You personally enrol at least 3 distributors to your frontline, each with at least 100 (or more) customer points (PCLP)
- You must have a Team Volume of at least 600 LP.

* **Team Volume** is the total orders made by your Customers (PCLP), plus the orders of your frontline distributors' customers. Personal orders, either your own or those of your frontline distributors, contribute to Team Volume.

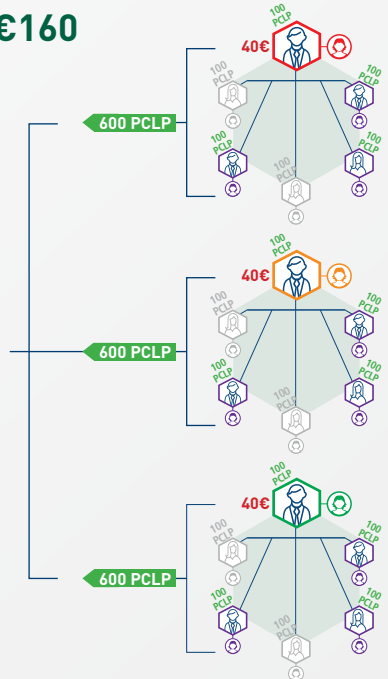
How to get a monthly bonus of €160

- You must be at the Builder or Diamond rank.



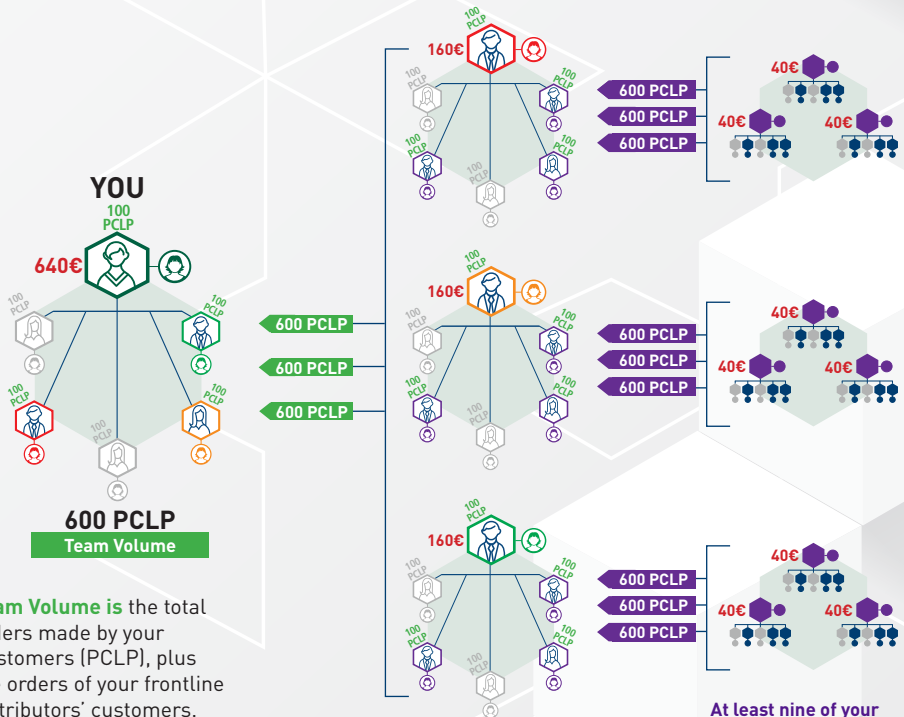
Each of your 3 (active) frontline distributors must have enrolled at least 3 other (active) distributors, **each of whom must have a Team Volume of at least 600 PCLP and fulfil the €40 Builder Bonus requirements.**

Each of the **3 members on your frontline must** meet the requirements for the monthly bonus of €40.



How to get a monthly bonus of €640?

- You must be at the Builder, Diamond or Presidential Diamond rank.
- Each of your frontline distributors** duplicates exactly what you have achieved, i.e. enrolls and activates at least 3 distributors on their frontline; each of whom must have a Team Volume of at least 600 PCLP.; And **each of your distributors on your second level** must duplicate the exact same model, in other words, enrol and activate at least 3 distributors on their frontline, fulfilling the Team Volume requirements with at least 600 PCLP. In this way, your 1st level will have at least 3 distributors; your 2nd level will have 9 distributors; and your 3rd level will have 27 distributors.



Team Volume is the total orders made by your Customers (PCLP), plus the orders of your frontline distributors' customers. Personal orders, either your own or those of your frontline distributors, contribute to Team Volume.

At least three of your (active), frontline distributors must fulfil the requirements for the monthly bonus of €160.

At least nine of your second level (active) distributors must fulfil the requirements for the monthly bonus of €40.

Each of the 3 members on your frontline and the nine Distributors on your second level must each have three members under them with a minimum **team volume of 600 LP**. Both yourself and the 3 members from your first level, as well as the 9 from your second level and the 27 from your third level must have a minimum of 100 PCLP order.

Distributor commissions vary according to several factors. The commissions stated in this brochure do not guarantee the same result but aim to demonstrate the commission that can be earned depending on how you develop your downline, on the capacity of the individual distributor and the extent of his dedication. All references to implicit or strategic earnings in the Life Rewards plan are purely for illustrative purposes. 4Life will not pay any commission for simply enrolling a new distributor in your downline.

NOTE: Promoted Customer Life Points (PCLP), required to activate the Life Rewards Plan for a distributor with an Italian code, must be from orders made by customers with an Italian code.

Frequently Asked Questions

- **How many Builder Bonuses can I receive?** You can earn 1 Builder Bonus per month. As long as you meet with all the qualification and Structure requirements.
- **Can I earn the Builder Bonus with my current structure or is it only for the newly-enrolled?** Starting 1st of April 2019, the Builder Bonus can be achieved with current and/or new distributors and New Preferred Customers
- **If I have ever reached the Diamond Rank, although I am currently at a Lower Rank, can I still receive additional 40 Builder Bonus? No, the Diamond rank can only receive the €160 or €640 Builder Bonus.**
- **If a person in the Builder Bonus structure withdraws, can he/she be replaced or do the structure has to be composed of the same three members?** Yes, the person that withdraws can be replaced.
- **Can I still receive the Builder Bonus if I have distributors from other markets (within my structure)?** Yes, provided they belong to a market that has a 4Life Office, i.e, they do not belong to emerging markets.
- **Se sono un Incaricato alle vendite Italiano posso utilizzare i punti provenienti da codici Clienti appartenenti a mercati esteri per attivare il Builder Bonus ed il Piano dei Compensi? If I am an Italian Distributor, can I use points from accounts belonging to foreign markets to activate the Italian Builder Bonus and compensation plan?** No, you can't use non-Italians Points (PCLP). Customer points required to enable compensation plan to an Italian Distributor, must come from promoting products to customers with Italian code.
